📽 Video Lectures

Structured exercises where learners complete statements or definitions by supplying missing terms. These activities promote attention to detail and reinforce vocabulary and conceptual accuracy.

Statement Activities

Learners evaluate and select correct statements from a set, promoting critical thinking and application of behavioral principles in context.

Podcasts and Audio Clips

Audio-based content that explores key topics in a conversational or narrative style. Often paired with reflection activities or comprehension checks to support auditory learners.

Stag-and-Drop Activities

Interactive modules where learners match terms to definitions, sort examples into categories, or complete sequences by dragging items to correct locations. These enhance engagement and facilitate active learning.

Memory Games

Gamified review tools that challenge learners to match terms with their corresponding definitions, examples, or categories, reinforcing recall through repetition.

Crossword Puzzles

Interactive crossword puzzles that reinforce terminology, definitions, and conceptual understanding in an engaging and visually stimulating format.

II Graphic Organizers

Visual learning aids such as charts, flow diagrams, and tables that help learners structure knowledge, see patterns, and summarize complex information for easier recall.

🛎 Flashcards

Digital flashcards that support fluency in ABA terminology. Learners can review definitions, examples, and key distinctions through repetition and self-assessment.
